



Agreement For Academic Cooperation and Exchange Between The Bronislaw Markiewicz State University of Technology and Economics in Jaroslaw, Poland And

Guangdong Polytechnic of Science and Trade

Declaration

The Bronislaw Markiewicz State University of Technology and Economics in Jaroslaw,
Poland and The Guangdong Polytechnic of Science and Trade
enter into the general agreement to promote international cooperation in education and research
between the Polish and Chinese Universities.

The State University of Technology and Economics in Jarolawis a public institution, that serves society, which carries out the powers expressly attributed to it by the law. It exercises its rights ordained by the law to perform the public service of higher education through research, teaching, and study.

The State University of Technology and Economics in Jarolawthrough the various faculties, departments and institutes and through its teaching and research staff, has among its objectives the research, teaching, and propagation of knowledge in various fields.

The State University exercises its rights to provide higher education courses at level 5, 6 and 7 of European Qualification Framework and extra-curricular modules.

Objectives

The goal of this agreement is to develop joint study programmes as well as foster cooperation and exchange programmes with regard to teaching, research, and student education, in the terms defined hereafter.

Types of cooperation

Agreement that this document creates is the foundation on which a productive and positive long term relationship between our Universities can be built.

Exchange activities below are examples of possible shared programs that can be implemented trough the partnership.

Cooperative initiatives include but are not limited to:

- Exchange of academic information and materials.
- Exchange of faculty and scholars (professors, lecturers).
- Exchange of students (including undergraduate and graduate students, TELC students, MA students studying minimum 5 Modules in one semester).
- Exchange of periodical academic publications.
- Organisation of joint conferences.
- Other academic exchanges agreed to by both parties.

The establishment of each exchange program, based on this agreement, will follow guidelines established by each university and shall be mutually acceptable to both institutions.

Both universities will offer as wide as possible selection of classes in English to fully accommodate exchange student's academic requirements and needs.

Both universities will cooperate to create all the opportunities to meet the academic, intellectual and creative needs of both institutions.

Nothing shall diminish the full autonomy of either institution nor will any constraints be imposed by either upon the other in carrying out the agreement.

This Agreement is made for an indefinite period of time. It may be terminated by each party with at least six months' notice. Any changes to this agreement shall be made in writing.

Academic staff

The staff assigned by each institution to carry out the educational activities must be accepted by both parties, strictly on the grounds of candidates professional aptitude for the tasks involved.

Financial conditions

Specific financial details will be defined separately for each programme, extra-curricular modules or project.

Coordination

Within a maximum period of three months, each Rector will nominate a person to be responsible for coordinating and supervising the activities to be carried out within the framework of this Agreement.

The coordinators will maintain regular contact with each other in order to promote cooperation between the Universities.
